Talk shows are eligible for the federal credit, the Canadian Film or Video Production Tax Credit administered by CAVCO, where principal photography began after February 16, 2016. CAVCO issued Public Notices 2017-02 and 2017-03 on March 6, 2017.

OFTTC Guidelines

These guidelines focus on the requirements a production must meet to be certified as a Canadian film or video production under the CPTC program. They also explain how the tax credit for a production is calculated, and the CRA's role in reviewing claims for the tax credit following the certification of a production through CAVCO.

Canadian Heritage Accessible Template

Producers seeking Canadian content certification, but who do not seek a federal tax credit, should apply to the CRTC. Canadian Audio-Visual Certification Office (CAVCO): Certifies domestic television and film productions and international treaty co-productions applying for the Canadian film or video production tax credit (CPTC). CAVCO also issues accreditation certificates to taxable Canadian corporations or foreign-owned corporations applying for the Film or Video Production Services Tax ...
