Gift of a Car in Florida - Important Details to Know

As the gift giver, you must sign over the Florida car title to the new owner (the one receiving the vehicle as a gift). Make sure you correctly fill out the blanks in the bottom portion of the Certificate of Title. Print your name and signature legibly, and remember to put the word GIFT by " selling price. "

In some states, the gift is exempt from an excise tax if the vehicle is given to an immediate family member. For example, in Maryland, you can request an exemption if the parties involved in the gift transfer are either a spouse, child, parent, grandparent, grandchild, stepchild, stepparent, half-sibling, son-in-law, daughter-in-law, mother-in-law or father-in-law.
